RULES and CONDITIONS

- The NZSSA Certificate of Capability (CoC) forms part of the NZSSA HOY Side Saddle Section Rules & Conditions of Entry & Qualification .
- This Certificate of Capability (CoC) is only for the Side Saddle Section at HOY.
- You must complete a separate (CoC) form for each horse/pony and rider combination.
- Please send in your CoC (scanned and emailed, or hard copy) as soon as it is completed to the appointed NZSSA HOY Convenor, J Pearce - jenny_taihape@hotmail.com
- DO NOT forward this CoC form to HOY
- You (the rider or supporting adult - for juniors) are responsible for getting your CoC completed and signed by each judge **at the show on the day of the show**.
- The deadline for the completed CoC to be with the Convener is 23 February 2020.
- A receipt/confirmation/acceptance will be sent for all CoC forms received– if you do not receive a receipt within 48 hours, please contact the appointed NZSSA HOY Convenor, as above.
- Qualification can be gained at any NZSSA Approved Shows = RAS affiliated shows, NZSSA Championship Show(NI &SI), Equidays, Auckland Easter Show, ESNZ Dressage (Registered or Unregistered) ,ESNZ Showjumping - where side saddle is allowed . Qualification competitions need not be specific side saddle classes.
- This CoC will not be accepted if incorrectly or untruthfully completed, or unsigned.
- Combinations who have won a side saddle class at HOY the previous year, are automatically fully qualified, and they DO NOT NEED to submit a CoC form, except the Turnout class winner who is **not** exempt.
- **Please complete the form details BEFORE asking a judge to sign it – the combination details -name of rider and horse or pony- MUST be completed before presenting this form to a judge to sign.**
